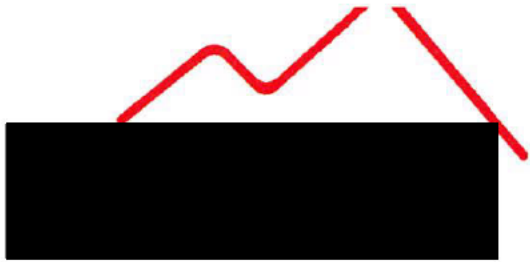

**ADDENDUM 1

The following questions have been submitted for clarification:

1. Does the county provide chemicals (Ecolab) for the dish machine, or does the contractor?
Answer: The chemicals for the dishwasher (Ecolab) are not purchased by Colleton County Detention Center.
2. What small ware, if any, are owned by the incumbent contractor? Answer: The current contractor owns the shadow board, can opener, dishcloths, and some of the measuring spoons.
3. How many sack meals are needed for court or work squads daily? Answer: The court meals vary, it depends on the amount requested during court time. As for "work squads," if you are referring to staff, the number is zero (0).
4. Can the county provide the previous contractor's billings? Answer: See attached.
5. Can the county provide the current contract documents, including any amendments?
Answer: See attached.
6. Was the staffing 1 – FSD, 1 full-time and 2 part-time employees? Answer: The current staff is one (1) FSD, two (2) full-time employees, and one (1) part-time employee.
7. Does the awarded contractor have the right to terminate for cause, and are there any specific terms provided? Answer: See page 6 of the RFP, item 14, TERMINATION OF PURCHASE.

WHEREAS, The Parties have agreed to extend with pricing adjustment the partnership; and

2. **Price.** Company shall charge and Client shall pay:


